Entry

To enter, individuals must be a current member or join the Iowa Lottery VIP Club. Entrants must legally acquire and submit an eligible Iowa Powerball with Double Play ticket. During the posted promotion period, entrants can scan and enter their eligible Powerball Double Play tickets with the Iowa Lottery LotteryPlus mobile app or manually enter the Powerball Double Play ticket number located on the front of the ticket. Each Powerball Double Play ticket entered with a value of \$3 or more will receive one entry in the promotion, regardless of the number of plays on the ticket or the ticket value. Players who enter Powerball Double Play tickets February 27 through 9:59 am CT May 6, 2024 will select one of the Iowa Speedway race prize categories for the ticket entry; a Grandstand tickets prize package, a VIP Experiences prize package, or the 3-day Grandstand tickets prize package. Players who enter Powerball Double Play tickets 10:00 a.m. May 6, 2024 through 9:59 a.m. June 19, 2024 will select one of the two prize categories for the ticket entry; the Trip Experience at Phoenix Raceway[®], or the \$1,000 cash and an Iowa Lottery semi-finalist entry for the NASCAR Powerball Playoff[™] Promotion. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The Iowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. June 19, 2024.

All entrants must be 21 years of age or older. A person can only win one race prize package per drawing category and per race day. Winners of the 3-day Grandstand prize package cannot win another Grandstand race day package. Winners of the VIP Suite Experience prize package for a race day cannot win the Grandstand ticket prize package for the same race day.

Drawings

The drawings for the Experience NASCAR[®] in Iowa promotion will be held on May 7, 2024 and June 20, 2024. The Iowa Lottery drawings will be held in accordance with the schedule posted to the Iowa Lottery's website (ialottery.com) and listed in the rules. The drawings will be held under the supervision of an independent auditor. All drawings of the Iowa Lottery are public events, and the Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the Iowa Lottery Security Division by telephone at 515-725-7900, by TTY Relay Iowa at 800-735-2942, or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the Iowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winners. Each winner will be sent an email to his or her VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline to claim their prize. Lottery offices are closed on weekends and state holidays. If a valid winner of an Experience NASCAR[®] in Iowa promotion prize does not present a fully executed claim form and the appropriate documents to the Lottery by the claim deadline, the prize package will be awarded to the first eligible alternate in the order they were drawn. If an alternate(s) is required for the prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Lottery website. If an alternate(s) is required for a prize, they must present a fully executed winner claim form and required documents to the lowa Lottery by the claim deadline listed in the notification email sent to the VIP Club member's email address.
