#### NASCAR® Race Weekend Promotion Rules

The NASCAR® Race Weekend promotion is an Iowa Lottery web-based Play It Again® promotion offering a total of 95 prizes (75 NASCAR race experiences at Iowa Speedway August 1-3, 2025, in Newton, Iowa; and 20 prizes of \$3,000 cash and an Iowa Lottery semi-finalist entry for the national NASCAR Powerball Playoff™ promotion).

The Iowa Lottery promotion, which can be entered by members of the Iowa Lottery VIP Club™ with eligible Iowa Lottery Powerball® Double Play® tickets, begins at 10:00 a.m. Central Time (CT) on Thursday, March 20, 2025, and its entry ends at 9:59 a.m. CT on Monday, June 23, 2025. The Iowa Lottery drawings will be held on Tuesday, June 24, 2025, for 15 VIP Race Weekend Suite Experience prize packages; 60 Grandstand Race Weekend prize packages; and 20 prizes of \$3,000 cash and an Iowa Lottery semi-finalist entry in the national NASCAR Powerball Playoff™ promotion. The Multi-State Lottery Association (MUSL) will conduct the drawings for the national NASCAR Powerball Playoff promotion winners.

The NASCAR Race Weekend promotion prizes are subject to lottery rules, validation procedures, set-offs and other deductions authorized by law. The race weekend prize packages include the required state and federal income tax withholding paid on the value of the prize package. There is no all-cash option for the race weekend prize packages. The lowa Lottery will withhold all state and federal taxes as may be required by law for the cash prizes. Winners are responsible for all other taxes that may be due and owing.

### **Entry**

To enter, an individual must be a current member of or join the Iowa Lottery VIP Club. Entrants must legally acquire and submit a winning or nonwinning Iowa Powerball Double Play ticket with a \$3 or more value.

Individuals enter the promotion as follows: During the eligibility period, entrants log into their VIP Club account on the lowa Lottery website, ialottery.com, to enter the promotion. On the lowa Lottery website, entrants will manually enter the ticket number located on the front of the eligible Powerball® Double Play® ticket or scan and enter the eligible Powerball Double Play ticket with the lowa Lottery LotteryPlus mobile app.

Each winning or nonwinning Powerball Double Play ticket entered with a value of \$3 or more will receive one entry in the prize category of the player's choice for either the VIP Race Weekend Suite Experience prize packages; Grandstand Race Weekend prize packages; or the prize packages of \$3,000 cash and an lowa Lottery semi-finalist entry in the national NASCAR Powerball Playoff promotion.

Players may enter multiple tickets, but an eligible Powerball Double Play ticket can be entered only once. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club. Entry of a Powerball Double Play ticket into the promotion is sufficient for presentation of a ticket for validations purpose for this promotion. Players will need to keep their Powerball Double Play tickets to claim any prize won in a multi-state Powerball drawing held each week on Monday, Wednesday and Saturday evenings.

# **Eligibility**

An eligible entry is any legally acquired lowa Powerball Double Play ticket purchased March 20, 2025 through 9:59 a.m. June 23, 2025 that has not been previously submitted on the lowa Lottery LotteryPlus app or through the lowa Lottery website as an entry into this promotion. Winning and nonwinning lowa Powerball Double Play tickets are eligible for entry in the promotion. All entrants must be 21 years of age or older. A person can only win one prize package per drawing category. However, an entrant cannot win both a VIP Race Weekend Suite Experience and a Grandstand Race Weekend prize package. If an entrant is selected as a winner of both prize packages, the entrant will be awarded the prize with the higher prize value and the prize package with the lower value will be awarded to an alternate. Winners of a VIP Race Weekend Suite Experience or Grandstand Race Weekend prize package can also win a prize package of \$3,000 cash with an lowa Lottery semi-finalist entry in the national NASCAR Powerball Playoff promotion.

Except as provided under the "lowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the lowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The lowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. June 23, 2025.

Players who have signed up for the lowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the lowa Lottery Commission, lowa Lottery employees, lowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the lowa Lottery, and their immediate families, as defined by statute, are not eligible.

## **Drawings**

The Iowa Lottery drawings for the NASCAR Race Weekend will be held on Tuesday, June 24, 2025. The Iowa Lottery drawings will be held in accordance with the schedule posted to the Iowa Lottery's website (ialottery.com) and listed in the NASCAR Race Weekend promotion rules.

The drawings will be held under the supervision of an independent auditor. All drawings of the lowa Lottery are public events and the lowa Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the lowa Lottery Security Division by telephone at (515) 725-7900, by TTY Relay lowa at (800) 735-2042, or by email directed to <a href="https://www.wmater.com"><u>WMaster@ialottery.com</u></a>. A request to observe a drawing must be received by the lowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Iowa Lottery's website and mobile app by the end of the day following the draw day or as soon as practicable following the determination of the winners. The winners will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawings or be present at the time of the drawings to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced and awarded.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline. The winners may present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Iowa Lottery offices are closed on weekends and state holidays.

The claim deadline for NASCAR Race Weekend promotion prizes is 4:00 p.m. Monday, July 7, 2025. If a valid winner of a prize does not present a fully executed lowa Lottery Winner Claim Form and the appropriate documents to the lowa Lottery by the claim deadline, the prize will be awarded to the next valid entrant in the order drawn. If an alternate is required for a prize, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the lowa Lottery website and mobile app. If an alternate is required for a prize, they must present a fully executed lowa Lottery Winner Claim Form and required documents to the lowa Lottery by 4:00 p.m. on the deadline date listed in the notification email.

By submitting an entry into the NASCAR Race Weekend promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the lowa Lottery, the lowa Department of Revenue, and the State of Iowa, its elected officials, apprentices, employees, agents, and volunteers, NASCAR, LLC, Iowa Speedway, LLC and Phoenix Speedway, LLC dba Phoenix Raceway (collectively the "Released Parties"). In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa, its employees, agents, or commission members, relating in any way to the promotion. The player also consents to the use by the Iowa Lottery and the Iowa Department of Revenue of their name or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a NASCAR Race Weekend promotion prize, the winner and their heirs, legal representatives, and assignees agree to indemnify, defend, release, and discharge the lowa Lottery, the lowa Department of Revenue, and the State of lowa, and each of their employees, officers, and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The lowa Lottery, lowa Department of Revenue, the State of lowa, and the Released Parties are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

The Multi-State Lottery Association will conduct the NASCAR Powerball Playoff™ elimination drawings to award the cash prizes of up to the \$1 million top prize in that national promotion. The results of each NASCAR Powerball Playoff™ drawing will be revealed during select race broadcasts, beginning with the Round of 16 national semi-finalists announced on August 23, 2025. Cash prizes will be awarded to all 16 national semi-finalists based on their elimination position, ranging from \$2,500 to the \$1 million prize. The drawing for the \$1 million winner will be broadcast live from the NASCAR Cup Series Championship™ Race at Phoenix Raceway in Arizona on November 2, 2025. Participating lottery jurisdictions at the time the lowa Lottery promotion begins include: Arizona, Delaware, Florida, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Minnesota, Mississippi, Nebraska, New Mexico, New York, North Carolina, North Dakota, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Wisconsin and Wyoming. Additional lotteries may join the national NASCAR Powerball Playoff promotion at a later time.

## NASCAR Powerball Playoff™ drawings and prizes:

- October 26, 2025 announced during the race at Martinsville Speedway, Martinsville, Virginia. 8 national semi-finalists narrowed to 4 finalists\*, the 4 semi-finalists eliminated win \$7,500 each;
- Nov. 2, 2025, at the NASCAR Championship Weekend<sup>™</sup> from among the 4 Finalists, 1 grand-prize winner of \$1 Million is selected (the 3 finalists eliminated win \$10,000 each). Live broadcast announcement during the NASCAR Cup Series Championship Race<sup>™</sup> at the Phoenix Raceway<sup>®</sup>, Avondale, Arizona.

#### Odds

The odds of winning a NASCAR Race Weekend promotion prize will vary depending on the number of entries.

## **Iowa Lottery Chief Executive Officer's Discretion**

If the lowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an lowa Lottery employee, lowa Lottery retailer, or lowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the lowa Lottery or its personnel.

#### Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.
