# Iowa Lottery Powerball Power Cruise Prize Structure

\* The stateroom awarded to the winner will be a Balcony, Ocean View or Interior determined by the drawing.

The promotion prizes are subject to lottery statues, rules, validation procedures, off-sets and deductions authorized by law. There is no cash in lieu of the cruise prize. The required state and federal withholding taxes on the value of the trip prize package are paid on the winners' behalf.

### Entry

Entrants must join or be a current member of the Iowa Lottery VIP Club and at least 21 years of age. Entry into the promotion is accomplished by legally acquiring and submitting an Iowa Powerball ticket in the promotion. Participants may scan or enter no more than one hundred (100) tickets per day during the promotional period.

Powerball ticket sales in the promotion will begin at the start of business on Saturday, April 14, 2018, and continue through 11:59 p.m. CT Wednesday, June 6, 2018. Players may enter as often as they wish by legally acquiring an Iowa Lottery Powerball ticket with a value of \$2 or more between April 14, 2018 and June 6, 2018. Players can enter the Powerball Power Cruise promotion by downloading the Collect 'N Win app from the app store (players will select Iowa from a drop down menu), and scanning the barcode from their eligible Iowa Powerball ticket; or by accessing the Powerball Power Cruise through the lottery website <u>www.ialottery.com</u> and manually entering their eligible Iowa Powerball ticket information.

Each game card within a player's account is made up of six (6) squares. For each eligible Iowa Powerball game ticket (which is scanned or entered into the promotion) a random quantity of 2, 4, 6, 8 or 10 of the five (5) available plays symbols will be randomly generated and placed in the first available game card. Players can have three (3) active cards open simultaneously. If a symbol is generated and Game Card #1 already has that symbol, it will be placed on Game Card #2, etc. In order to generate an entry, a registered player must complete the 6-symbol card (5 symbols plus one free). Once a card is completed, an entry is automatically generated for the player and submitted; the card will be reset to capture more symbols on that cleared card and collect symbols toward the next entry. Entry into the Powerball Power Cruise promotion is sufficient for presentation of a Powerball ticket for validation purposes for this promotion. Players do not need to keep their Powerball tickets after entering them for the promotion. However, players will want to keep their Powerball tickets until the Powerball drawing for which they're eligible, as they would need their ticket to claim any cash prize won in a Powerball drawing. All entries must be received before the Entry Submission End Dates listed in the Powerball Power Cruise Drawing Schedule.

## Eligibility

All valid Powerball tickets legally acquired in Iowa from April 14, 2018 through June 6, 2018 are eligible for the Power Cruise promotion. Players can scan or enter the numbers on their Powerball ticket during the promotion to collect cruise vacation symbols. Each ticket number can only be scanned or entered one time. When the player has completed the 6-symbol card, an entry will be automatically generated.

Entries must be submitted prior to 11:59 pm (CT) on the Entry Submission End Date to be included in that drawing. Entries not selected in drawings 1 or 2 will roll to the next eligible drawing. Entries not selected in the third and final drawing will not be eligible for any prize. Entries received after the Entry Submission End Date for the final drawing are not eligible for a promotional drawing prize. A person can win only one Powerball Power Cruise prize.

## Powerball Power Cruise Prize Drawing Schedule

Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Authority Board of Directors and Iowa Lottery Authority employees and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families as defined by statute, are not eligible.

## Drawings

The drawings will be held in accordance with the rules and the schedule posted to the Lottery's website. The Powerball Power Cruise promotion drawings will be conducted by Alchemy3 on behalf of the Iowa Lottery and held under the supervision of an independent auditor.

The winners' names will be posted on the Lottery's website by the end of the second day following the draw day or as soon as available. Each selected winner will be sent an email to his or her VIP Club member address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to be determined a winner. Each of the selected entries will be verified. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced. If the entry number drawn is determined to be ineligible for any reason or the winner of a Powerball Power Cruise prize does not present a fully executed claim form and required documentation by the claim deadline, the prize will be awarded to the first valid alternate. If alternates are required, an email notification will be sent to the alternate's VIP Club email address and his/her name will be posted on the Lottery website. If an alternate is required, he or she must present a fully executed winner claim form and required documents to the Iowa Lottery by 4:00 p.m. CT 15 business days from the drawing date to claim the prize.

The prize winners in the Powerball Power Cruise promotion drawings must complete and sign a winner claim form along with appropriate documentation and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline to claim their prize. Alchemy3 will pay the required State and Federal withholding taxes on behalf of each winner. Each winner will receive a W2-G tax withholding form from Alchemy3.

By submitting an entry into the Powerball Power Cruise promotion and claiming the prize, the entrant certifies he or she is the sole owner of the entry, the entry is valid pursuant to these rules, the entrant is at least 21 years old, the ticket is not stolen, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the State of Iowa and the Iowa Lottery Authority, its elected officials, apprentices, employees, agents and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the State of Iowa, the Iowa Lottery, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery of his or her name and/or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Power Cruise prize, the winner and his or her guest, heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the Iowa Lottery, State of Iowa, Alchemy3, and Multi-State Lottery Association, its employees, officers and directors from and against any loss, claim, damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules.

If for any reason the original prize winner and/or guest cannot attend the Power Cruise sailing on January 19, 2019, they may assign a Proxy to sail in their stead. At the request of the prize winner, and with the approval of the Iowa Lottery, the necessary arrangements for the winner to transfer the trip can be made prior to the booking deadline at no additional cost to the winner. If the need for a Proxy is determined after travel booking arrangements have been made for the original prize winner, the winner will be responsible for all additional expenses incurred for booking travel for the proxy. Proxy paperwork must be submitted by Wednesday, October 31, 2018.

In the event that a Power Cruise prize winner is unable to attend the cruise due to unforeseen and reasonable circumstances, and does not complete the appropriate paperwork to appoint a proxy to take the cruise on his/her behalf, that winner is subject to the full prize reporting and withholding. If the winner and/or guest do not board the ship in time for sailing, there will not be an alternate sail date provided or credit towards another cruise and the winner will not receive any reimbursement for the trip value.

### Odds

The odds of winning a Powerball Power Cruise promotion prize will vary depending on the number of entries.

## Iowa Lottery Authority CEO's Discretion

If the CEO, or the CEO's designee, determines that an otherwise valid entry has been foiled by any human or technical error, whether by a Lottery employee, Lottery retailer or Lottery vendor, the CEO may authorize the replacement of an eligible entry or a refund of the ticket price. This shall be the player's only recourse against the Lottery or its personnel.

### Force Majeure

If the Iowa Lottery Authority is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the Iowa Lottery Authority, the Iowa Lottery Authority shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

#### Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court of the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Lottery or the State of Iowa.

The Iowa Lottery is not responsible for and shall not be liable for:

- Otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after the entry deadline;
