Summer of Music Promotion Rules

The Summer of Music promotion is an Iowa Lottery VIP Club web-based Play It Again[®] promotion offering concert prize packages to the IndyCar Race Weekend July 22 and 23 in Newton at the Iowa Speedway and the Iowa State Fair August 10—20, 2023, in Des Moines.

This promotion, which can be entered by members of the VIP Club with eligible \$10 Wild Cherry scratch tickets, begins at 10:00 a.m. Central Time (CT) on Tues., June 6, 2023 and its entry period ends at 9:59 a.m. CT on Mon. July 31, 2023. There are two entry periods for the prizes and two draw dates during the promotion. The first draw date is July 6 for a total of 190 lowa Speedway IndyCar Concert prize packages and the second draw date is August 1 for a total of 20 lowa State Fair Concert prize packages.

The Summer of Music promotion prizes are subject to lottery rules, validations procedures, off-sets and deductions authorized by law. The Summer of Music VIP Suite IndyCar Concert prize package includes the required state taxes paid on behalf of the winners. The lowa Lottery will withhold all state and federal taxes as may be required by law. The winners are responsible for all other taxes that may be due and owing.

Entry

Entrants must join or be a current member of the lowa Lottery VIP Club. Entry into the promotion is accomplished by legally acquiring an eligible \$10 Wild Cherry scratch ticket. If the ticket is a nonwinner, players can log in to their VIP Club account at the lowa Lottery website, ialottery.com, to enter the Summer of Music promotion with the entry number (located on the front of the ticket) and the ticket number (located on the back of the ticket above the bar code) or scan the ticket to enter with the lowa Lottery LotteryPlus mobile app.

Each nonwinning Wild Cherry ticket entered will receive one entry in the promotion. Players who enter Wild Cherry tickets June 6 through 9:59 a.m. July 5, will select the IndyCar Race Weekend prize category for the ticket entry, either the July 22 VIP Suite or Grandstand prize package or the July 23 VIP Suite or Grandstand prize package. Players who enter Wild Cherry tickets starting at 10 am on July 5 through 9:59 am July 31 will select the Iowa State Fair concert prize category for the ticket entry.

Players may enter multiple tickets, but an eligible scratch ticket can be entered only once. VIP Club members can enter multiple times during the promotion, and in more than one category, and each person may win a concert prize package in each prize category they enter. Winning scratch tickets are not eligible for entry into this promotion. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club. Entry of a nonwinning scratch ticket into the promotion is sufficient for presentation of a ticket for validation purposes for this promotion. Players do not need to keep their nonwinning scratch tickets after entering them in the promotion.

Eligibility

An eligible entry is any legally acquired Iowa Lottery Game #658 Wild Cherry nonwinning scratch ticket that has not been previously submitted as an entry into this promotion on the Lottery website or the Iowa Lottery Lottery Plus app.

Except as provided under the "CEO's Discretion" herein below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time as specified on the lowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The lowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. July 31, 2023. A player could win one concert prize package for each concert they enter.

All entrants must be 21 years of age or older. A person can win more than one concert prize package during the promotion; however, they can win only one prize per category drawing.

Players who have signed up for the lowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the lowa Lottery Board of Directors and lowa Lottery employees and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

There will be two lowa Lottery draw dates during the promotion. The drawing for the 190 winners for the July 22 and July 23 concert prize packages will be held on July 6, 2023. The drawings for the 20 winners for the August 10–20 concert prize packages will be held on August 1, 2023. Drawings will be held in accordance with the schedule posted to the Lottery's website (ialottery.com) and listed in the rules. The promotion drawings will be held under the supervision of an independent auditor. All drawings of the lowa Lottery are public events. Persons interested in observing drawings are invited to receive detailed information by contacting the lowa Lottery Security Division at 515/725-7900; TTY Relay lowa at 800/735-2942; or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website and mobile app by the end of the day following the draw day or as soon as available. Each selected winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to be determined a winner. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced. The prize winners for the July 6

promotion drawings must complete and sign a winner claim form along with appropriate tax documentation and present those documents with a legible copy of their government-issued photo identification to the lowa Lottery by 4 p.m. Friday, July 14, 2023, to claim their prize. Winners for the August 1 promotion drawings must complete and sign a winner claim form along with appropriate tax documentation and present those documents with a legible copy of their government-issued photo identification to the lowa Lottery by 4 p.m. Monday, August 7, 2023, to claim their prize.

The winners of a Summer of Music promotion prize must present the completed documents at any Iowa Lottery regional office, open Monday through Friday from 8:00 a.m. to 4:00 p.m., by utilizing the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Lottery offices are closed on state holidays. If a valid winner of a July 6 drawing prize package does not present a fully executed claim form and the appropriate documents to the Lottery by 4:00 p.m., July 14, 2023, the concert prize package will be awarded to the first eligible alternate in the order they were drawn. If an alternate(s) is required for the July 6 drawing prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Lottery website. If an alternate(s) is required for the prize package, they must present a fully executed winner claim form and required documents to the Iowa Lottery by 4 p.m. Wed., July 19. If a valid winner of a August 1 drawing prize package does not present a fully executed claim form and the appropriate documents to the Lottery by 4:00 p.m., Mon., August 7, 2023, the concert prize package will be awarded to the first eligible alternate in the order they were drawn. If an alternate(s) is required for the August 1 drawing prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Lottery website. If an alternate(s) is required for the August 10-14 concert prize package, they must present a fully executed winner claim form and required documents to the Iowa Lottery by 4 p.m. Wed., August 9, and alternates for the August 15-20 concerts must claim their prize by 4 p.m. Fri., August 11, 2023.

By submitting an entry into the Summer of Music promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket is not stolen, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the State of Iowa and the Iowa Lottery, its elected officials, apprentices, employees, agents and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the Iowa Lottery, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery of their name and/or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Summer of Music promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the lowa Lottery, State of lowa, and its employees, officers and directors from and against any loss, claim damage, suit or injury arising out of or relating to the promotion or any action taken pursuant to these rules.

Odds

The odds of winning a Summer of Music promotion prize will vary depending on the number of entries.

Iowa Lottery CEO's Discretion

If the CEO, or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of a Lottery employee, Lottery retailer or Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the Lottery or its personnel.

Force Majeure

If the lowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the lowa Lottery, the Lottery shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Lottery or the State of Iowa.

Technical Disclaimer

The lowa Lottery is not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from https://www.ialottery.com or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or

• Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the lowa Lottery is not responsible for incomplete, illegible, misdirected, late, lost, damaged or stolen entries; or for lost, interrupted, inaccessible or unavailable networks, satellites, Internet Service Providers (ISP), website or other connections; or for miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmission; or for any technical malfunctions, failures or difficulties; printing errors; clerical, typographical or other error in the offering or announcement of any prize or in any prize notification documents, or other errors of any kind or nature; or for the incorrect or inaccurate capture of information or the failure to capture information.

Caution: Any attempt by anyone to deliberately damage the website or undermine the legitimate operation of the promotion may be in violation of criminal and civil laws and will result in disqualification if the individual is an entrant. If such an attempt is made, the lowa Lottery reserves the right to seek remedies and damages from any such person to the fullest extent of the law, including criminal prosecution. The lowa Lottery, in its sole discretion, reserves the right to cancel the promotion if the system through which the promotion is operated has become technically corrupted or if the integrity of the promotion has in any way been compromised.
