# **Fair Fever Promotion Rules**

The Fair Fever promotion is an lowa Lottery VIP Club<sup>™</sup> web-based Play It Again<sup>®</sup> promotion offering concert prize packages to nine lowa State Fair Grandstand concerts and cash prizes. The cash prize amounts will be determined during a live game show on the Fair's Grand Concourse on Thursday, August 8, the first day of the 2024 Iowa State Fair. The promotion, which can be entered by members of the VIP Club with eligible \$5 Iowa State Fair scratch tickets, begins at 3:00 p.m. Central Time (CT) Tuesday, April 16, 2024, with entries accepted through 9:59 a.m. on Tuesday, July 16, 2024. There are two entry periods and draw dates for the concert prize packages. The first draw date is June 6, 2024 and the second draw date is July 18, 2024. The 20 winners of Game Show Contestant Prize Packages will participate as contestants in a live event at the Iowa State Fair on Thursday, August 8, 2024, where each contestant is guaranteed a cash prize of at least \$10,000. The final contestant on the game show will win a cash prize of at least \$500,000 and have a chance to win up to \$5 million.

**Game Show**: The Fair Fever promotion will include a live lottery game show on Thursday, August 8, 2024 at the Iowa State Fair on the Grand Concourse, where 20 Iowa Lottery Game Show Contestant Prize winners will participate. The 20 contestants will compete for a total of \$1 million in guaranteed cash prizes and the final contestant in the game show will have a chance at a prize of up to \$5 million. <u>Round One</u>: 6 prizes of \$10,000; 3 prizes of \$15,000; and 1 prize of \$20,000. 10 Finalists will advance to Round Two. <u>Round Two</u>: 6 prizes of \$25,000; 1 prize of \$50,000; 1 prize of \$75,000; and 1 prize of \$100,000. 1 will advance as a Finalist to the Final

Round Two: 6 prizes of \$25,000; 1 prize of \$50,000; 1 prize of \$75,000; and 1 prize of \$100,000. 1 will advance as a Finalist to the Final Round.

Final Round: 1 Finalist will win at least \$500,000 and have the chance to win up to \$5 million.

The Fair Fever promotion prizes are subject to lottery rules, validation procedures, set-offs and deductions authorized by law. The lowa Lottery will withhold all state and federal taxes as may be required by law for the cash prizes. Winners are responsible for all other taxes that may be due and owing.

## Entry

To enter, an individual must be a current member or join the lowa Lottery VIP Club. Entrants must legally acquire and submit a nonwinning lowa State Fair scratch ticket (Game # 708). Individuals enter the promotion as follows: During the eligibility period, entrants log in to their VIP Club account on the lowa Lottery website, ialottery.com, to enter the promotion. Entrants can scan and enter the eligible lowa State Fair scratch tickets with the lowa Lottery LotteryPlus mobile app, or manually enter the scratch ticket numbers (located on the front of the ticket in the scratch-off area and the back of the ticket) on the lowa Lottery website at ialottery.com.

Players can enter nonwinning Iowa State Fair scratch tickets into the promotion beginning at 3 p.m. April 16, 2024. Each nonwinning Iowa State Fair scratch ticket entered will receive one entry in the promotion. Players who enter eligible Iowa State Fair tickets April 16 through 9:59 a.m. June 5, 2024, will select either the Game Show Contestant category or Lauren Daigle or Foreigner or Jelly Roll or Greta Van Fleet Iowa State Fair Concert prize categories. Players who enter Iowa State Fair tickets starting at 10:00 a.m. on June 5 through 9:59 a.m. July 16, 2024, will select either the Game Show Contestant category or the Brett Young or Thomas Rhett or Mötley Crüe or The Avett Brothers or Ne-Yo Iowa State Fair Concert prize categories. Players may enter multiple Iowa State Fair scratch tickets, but each eligible ticket can be entered only once.

# Eligibility

An eligible entry is any legally acquired nonwinning Iowa Lottery Game #708 Iowa State Fair scratch ticket that has not been previously submitted on the Iowa Lottery LotteryPlus app or through the Iowa Lottery website as an entry into this promotion.

Except as provided under the "lowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the lowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The lowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. July 16, 2024. A player could win a concert prize package to each performer's concert they enter.

All entrants must be 21 years of age or older. A person can only win one concert prize package per concert date and only one opportunity to participate as a game show contestant.

Players who have signed up for the lowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the lowa Lottery Board of Directors, lowa Lottery employees, lowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

#### Drawings

The lowa Lottery drawings for the Fair Fever promotion will be held on Thursday, June 6, 2024, and Thursday, July 18, 2024. The lowa Lottery drawings will be held in accordance with the schedule posted to the lowa Lottery's website (ialottery.com) and listed in the Fair Fever promotion rules.

The drawings will be held under the supervision of an independent auditor. All drawings of the lowa Lottery are public events and the Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the lowa Lottery Security Division by telephone at (515) 725-7900, by TTY Relay lowa at (800) 735-2942, or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the lowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winners. Each winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline. The claim deadline for the June 6, 2024, promotion drawings is by 4:00 p.m. June 27, 2024. The claim deadline for the July 18, 2024, promotion drawings is by 4:00 p.m. August 1, 2024. The winners may present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Lottery offices are closed on weekends and state holidays.

If a valid winner of a Fair Fever prize package does not present a fully executed Iowa Lottery Winner Claim Form and the appropriate documents to the Iowa Lottery by the claim deadline, the prize will be awarded to the next valid entrant in the order drawn. If an alternate(s) is required for a prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Iowa Lottery website and mobile app. If an alternate(s) is required for a Fair Fever prize package, they must present a fully executed Iowa Lottery Winner Claim Form and required documents to the Iowa Lottery by 4:00 p.m. on the deadline date listed in the notification email.

By submitting an entry into the Fair Fever promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its elected officials, apprentices, employees, agents, and volunteers. In consideration for participating in the promotion, the entrant may have or ever claim to have against the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery and the lowa Department of Revenue of their name or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Fair Fever promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the lowa Lottery, the lowa Department of Revenue, and the State of lowa, and each of their employees, officers,

and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The lowa Lottery, lowa Department of Revenue, and the State of lowa are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

Atlas Experiences, LLC will conduct the live game show series of elimination rounds where cash prizes will be awarded to all 20 Fair Fever game show contestants. SCA Promotions, Inc. will oversee the top prize drawing where the final contestant will have the chance to win up to \$5 million.

# Odds

The odds of winning a prize in the Fair Fever promotion will vary depending on the number of entries.

## Iowa Lottery Chief Executive Officer's Discretion

If the Iowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an Iowa Lottery employee, Iowa Lottery retailer, or Iowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the Iowa Lottery or its personnel.

### Force Majeure

If the lowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the lowa Lottery, then the lowa Lottery, the lowa Department of Revenue, and the State of lowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

#### Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.

## **Technical Disclaimer**

The lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from https://www.ialottery.com or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or
- Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entries; lost, interrupted, inaccessible, or unavailable networks, satellites, Internet Service Providers (ISPs), websites, or other connections; miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or any technical malfunctions, failures, or difficulties; printing errors; clerical, typographical, or other errors in the offering or announcement of any prize or in any prize notification documents; the incorrect or inaccurate capture of information or the failure to capture information; or other errors of any kind or nature.

Caution: Any attempt to deliberately damage any website related to the lowa Lottery, the lowa Department of Revenue, and the State of lowa or to undermine the legitimate operation of the promotion may be in violation of criminal and civil laws and will result in disqualification if the individual is an entrant. If such an attempt is made, the lowa Lottery, the lowa Department of Revenue, and the State of lowa reserve the right to seek remedies and damages from any such person to the fullest extent of the law, including criminal prosecution. The lowa Lottery, the lowa Department of Revenue, and the State of lowa, in each entity's sole discretion, reserve the right to cancel the promotion if the system through which the promotion is operated has become technically corrupted or if the integrity of the promotion has in any way been compromised.
