MINUTES IOWA LOTTERY BOARD

March 24, 2020 10:30 a.m.

The Iowa Lottery Board convened at 10:30 a.m. via conference call; Board Chairperson Mary Junge presiding.

CALL TO ORDER

Chairperson Junge called the meeting to order at 10:30 a.m. and roll was taken. There was a quorum. Junge announced the meeting would be held via teleconference in accordance with Iowa Code section 21.8.

Cook moved to conduct the meeting via teleconference. Rathje seconded. Motion carried unanimously.

APPROVAL OF AGENDA

Quinn moved to approve the agenda for the meeting. Rathje seconded. Motion carried unanimously.

APPROVAL OF MINUTES

Cook moved to approve the December 12, 2019 board meeting minutes. Quinn seconded. Motion carried unanimously.

CEO UPDATE

Strawn recognized and congratulated Board Chair, Mary Junge, on her recent re-nomination by Governor Kim Reynolds to the Iowa Lottery Board.

Strawn discussed the steps the Lottery has taken to prepare for and respond to the public health emergency. Preparation has meant making sure lowans know that the Lottery is still open for business, supporting players and retailers, and continuing to generate revenue for the State of Iowa, in addition to performing these functions under new procedures and protocols to mitigate the risk of COVID-19 exposure to personnel and the public.

Strawn stated the sales of Lottery products through Saturday, March 21st, have generally remained stable and consistent with weekly sales data.

Strawn provided the Board a summary of departmental quarterly reports. Strawn also expressed his appreciation to Lottery employees for their dedication to a culture of collaboration while serving lowans.

CENTRAL GAMING SYSTEM RFP RECOMMENDATION

Loss and Tooker presented information related to the Computer Gaming System RFP. Loss said the Iowa Lottery's current contract for its computer gaming system covered seven years and allowed for three one-year extensions. The Lottery has exercised all of the extensions associated with the existing contract and was required to go out to bid for a new gaming system. Lottery staff members spent numerous hours developing and writing a Request For Proposals (RFP) for a computer gaming system and related services.

Loss stated the Lottery issued RFP IL 20-01 for the implementation of a computer gaming system with associated gaming and communications products and services. The system will provide terminals, kiosks, retailer displays and jackpot signs, together with all related computer hardware and software.

The deadline to submit proposals for the RFP was November 15, 2019. Proposals were received from 3 vendors: IGT Global Solutions Corporations (IGT), Intralot, Inc. (Intralot), and Scientific Games International, Inc. (SGI). Members of the evaluation committee reviewed and evaluated the information contained in the vendor proposals and ensured that all vendors were treated equally and impartially throughout the process. The committee first evaluated and scored the vendors' technical proposals. Once the technical proposals were scored, the pricing proposals were opened and scored.

The pricing proposals were opened and scored by the RFP coordinator and the internal auditor. Once the pricing proposals were scored, the results were provided to the evaluation committee and added to the technical scores.

There were 700 technical points and 300 pricing points available. The final scoring was:

Loss stated Scientific Games International, Inc. received the highest point total in the evaluation process. Loss explained the objectives for issuing the RFP, the RFP timeline and the RFP Evaluation process.

Tooker discussed the evaluation committee's site visits to IGT, Intralot and Scientific Games. During the site visits, the vendors each gave a presentation of their proposal, demonstrated their system's capabilities and answered questions from committee members. Tooker stated that the evaluation committee was impressed with all three vendors and their proposals.

Loss stated that based on the final scoring, it is the evaluation committee's recommendation that the Lottery Board issue a Notice of Intent to Award to Scientific Games International, Inc. subject to the successful completion of a DCI background investigation. SGI has been the Lottery's vendor for over eighteen years. SGI and IGT were virtually tied in the technical scoring. However, SGI's pricing for the baseline system and options was much lower than the other two vendors, which comes through in the

overall score. While all three vendors have their strengths, SGI's proposal offers a strong gaming system at the lowest price with minimal retailer disruption during the implementation phase. It is anticipated SGI's implementation of the new system and related products and services will be efficient and effective in part because the Lottery and its retailers are familiar with SGI and its local staff. SGI is proposing a phased implementation whereby it swaps out the old retail terminals and associated equipment for the new terminals and equipment. This swap will cause minimal disruption at each retailer and will avoid retailers having two terminals and associated equipment on the counter (one from the current vendor and one from the new vendor) for a period of time. By remaining with SGI, the evaluation committee also anticipates a seamless integration of the Lottery's current games into the new system. Awarding the contract to SGI meets the objectives of the RFP.

Hanson moved to approve the RFP evaluation committee's recommendation to issue a Notice of Intent to Award to Scientific Games International, Inc. Cook seconded. Motion carried unanimously.

CONTRACT EXTENSIONS

Loss discussed the Lottery's desire to extend the term of the Second Extension for the current On-line Gaming System contract with Scientific Games (SGI) by 7 days - from July 4, 2021 to July 11, 2021 - in order to avoid converting to a new central gaming system during the Independence Day holiday.

Wood stated that at its May 2020 meeting, the Iowa Lottery Board approved an award to Strategic America for the advertising/creative contract and to Bucket Media Company for the media services contract.

Wood stated the Iowa Lottery seeks to exercise the first extension period available under each of these agreements, so that the parties can continue to work together to achieve great results for Iowans.

Wood requested that the Board approve the exercise of the first of four available extension of the advertising/creative agreement with Strategic America and the media services agreement with Bucket Media Company, making the term run through June 30, 2021.

Rathje moved to approve the Contract Extensions for Scientific Games, Bucket Media and Strategic America. Quinn seconded. Motion carried unanimously.

CONSULTING CONTRACT

Tooker stated it would be beneficial to have one or more consultants assist the Lottery with services related to its conversion to a new gaming system. Therefore, the Lottery issued a Request for Bids asking for pricing for the following service: Contract negotiation and drafting and reviewing and developing software specs for the computer gaming system.

Tooker said the Lottery received only one bid; from Delehanty Consulting LLC. Delehanty Consulting specializes in lotteries and has worked for or with 39 of the 46 lotteries in the United States, including the lowa Lottery. Delehanty Consulting submitted a bid of \$20,000 for contract negotiating and drafting and a bid of \$26,000 for reviewing and developing software specifications for a total of \$46,000 plus any approved travel expenses.

Tooker stated that staff recommends the Board authorize the Lottery to contract with Delehanty Consulting for one or both of these services.

Quinn moved to approve the Consulting Contract. Rathje seconded. Motion carried unanimously.

FINANCIAL UPDATE

Conroy gave a financial report. February sales are \$175K over budget. Sales for the fiscal year-to-date are nearly \$6.7M or 2.92% ahead of budget. Expenses for the fiscal year-to-date are \$1.5M or 15% below budget. Proceeds to the State for the fiscal year-to-date are \$4.6M or 9.78% ahead of budget; and \$4.1M lower than the 5-year average.

Cook moved to approve the Financial Report. Hanson seconded. Motion carried unanimously.

MEMBERSHIP DUES

Loss stated for many years, the Iowa Lottery has participated as a member of the Iowa Grocery Industry Association (IGIA), FUELIowa, the North American Association of State & Provincial Lotteries (NASPL) and the World Lottery Association (WLA). The Board approves all memberships for the Iowa Lottery.

Loss asked the Board for approval to continue membership in IGIA (\$500), FUELIowa (\$688) and WLA (5,600 Swiss Francs; which is approximately \$5,783.75 at the current exchange rate).

Rathje moved to approve the membership dues. Cook seconded. Motion carried unanimously.

Quinn complimented Lottery staff on their handling of the RFP and the COVID-19 crisis. Fitzgerald agreed with Quinn.

ADJOURNMENT

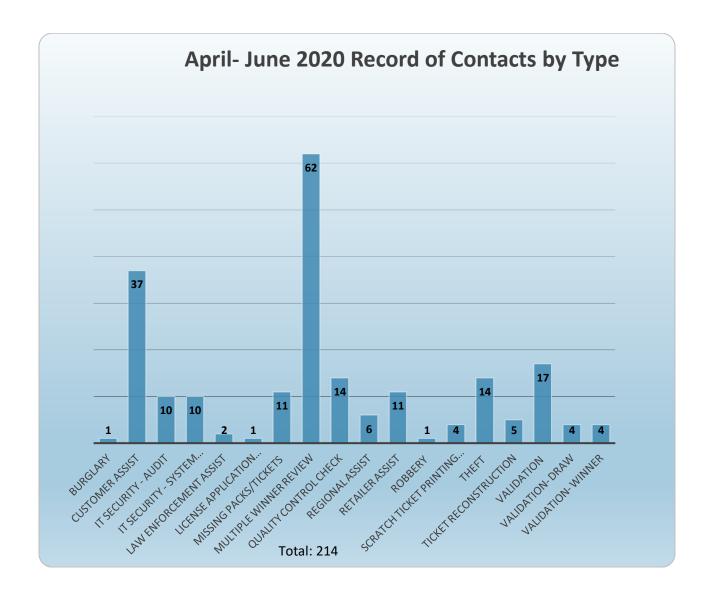
Quinn moved to adjourn. Hanson seconded. Motion carried unanimously.

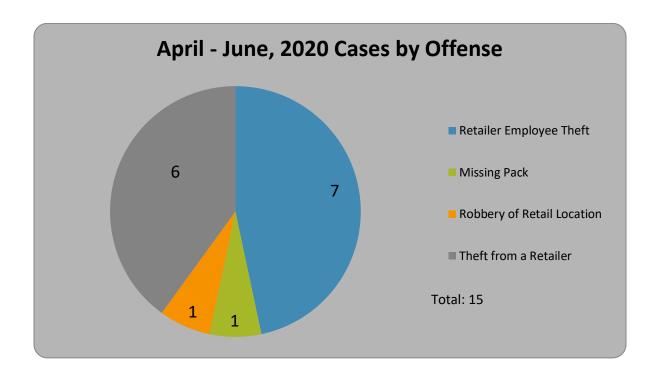
June 2020 Board Report Security Division





Multiple Winner Reviews are conducted bi-annually. Security Investigators review player wins for players who have won two or more prizes of \$600 or above. The review is completed to ensure the integrity of the Lottery.

Customer Assist describes instances in which Lottery Security Investigators respond to customer inquiries. The topics are varied, and generally player questions for which they are seeking explanations.



Other Duties and Activities;

- Conducted **144** compliance/inspection checks on retail outlets, sent follow up letters to all retailers to provide results of the compliance check at their store

External Relations Report To Iowa Lottery Board

The lowa Lottery's External Relations team has had a busy start to 2020, working to highlight and explain the daily work of the lottery while also giving support to other important lowa initiatives.

2020 Census

In early April as U.S. households began receiving official mail from the U.S. Census Bureau providing details about how to complete the 2020 Census, the lowa Lottery highlighted the importance of lowans' participation in the once-in-a-decade count.

We shared information on social media, ran special Census messages at the top of all lotto

tickets purchased in Iowa, and displayed Census messages on the screens at our lottery terminals and on our self-service kiosks.

A complete and accurate Census count helps ensure that we as lowans receive the political representation we deserve and that our taxpayer dollars are spent in a way that helps our state.

lowa had top ranking in 2000 in getting its residents counted, with 76 percent of households in the state returning their Census forms. And in 2010, lowa helped lead the way



in the mail-in process for the Census, with 78 percent of households sending back their forms.

After a two-week campaign to highlight the Census in early April, the lottery continued to run Census messages on its lotto tickets for one-week intervals through the end of May.

Shown above is an image of a point-of-sale screen displaying our Census message, and below are some of the messages we printed on lotto tickets to encourage Census participation. We are gratified that the lottery was able to utilize its creativity to highlight the importance of lowans' participation in the Census.

National Problem Gambling Awareness Month



At the beginning of March, the Iowa Lottery emphasized its core principle of responsible play by highlighting National Problem Gambling Awareness Month.

The lottery reached out to radio, television and cable companies as well as digital outdoor billboard providers statewide with a request that they provide public-service announcements about National Problem Gambling Awareness Month and the help available all across lowa for those struggling with problem gambling. The public-service messages were co-branded by the lottery and the lowa Department of Public Health, and the lottery further amplified the message by providing information across its social media platforms.

During the first week in March, the public-service announcements were provided thousands of times across the state, with a combined media value of more than \$300,000. Lottery staff also participated in a Statehouse event where Gov. Kim Reynolds signed a proclamation recognizing National Problem Gambling Awareness Month in Iowa.

In a case of fortuitous timing, this initiative occurred during the first week of March, which allowed the responsible-gaming message to receive strong attention before the COVID-19 emergency was declared in our state later that month.

Curbside Prize Claims

As the lowa Lottery continues to find its way forward amid the COVID-19 pandemic, we're pleased to report that the curbside prize-claim option we added in early June has been well received by our players.

Public access to lottery offices has been restricted to email and telephone since mid-March as we do our best to help mitigate the spread of the virus. When we initially put those restrictions in place, prize claims could be mailed or shipped to our headquarters location in Clive or left in a secure dropbox there. Players generally were understanding of the restrictions and said they appreciated the lottery's efforts to protect everyone's health.

As state restrictions began to be lifted in May, we discussed how the lottery could again allow prize claims in person while continuing to protect the operational integrity of the lottery against COVID-19.

On June 1, we implemented curbside prize claims by appointment at our offices in Storm Lake, Mason City, and Cedar Rapids. We then implemented curbside claims by appointment at our headquarters location on June 8.

To make the details about curbside claims easy to find, we have kept information about it on the homepage of our website since we announced the option. Here is a direct link to that information:

The process has gone smoothly and players have expressed that they're glad to be able to interact with us in person again. Some players, as you might anticipate, have come forward to utilize curbside claims without having an appointment, and our staff has been able to assist them while honoring the appointments made by others.

During curbside claims, players claiming prizes remain in their vehicles, and a lottery staffer



wearing a facemask or face shield and protective gloves takes prize-claim paperwork out to them, then helps them accurately complete it before returning to the lottery office to process the paperwork and winning ticket. When that process is complete, a lottery staffer takes the check payment for the player's prize back out to them.

The biggest challenge we have faced thus far of course has been the weather, but Mother Nature has been relatively kind to us during our initial weeks of this process.

We plan to continue curbside prize claims at te collectively evaluate the COVID-19 impact in

our offices for the near future as we as a state collectively evaluate the COVID-19 impact in lowa.

New Website Page Showing How Iowa Lottery Helps State

Earlier this month, we debuted a new page on the lowa Lottery's website to provide an updated look at how the money spent on lottery tickets is used in our state, and the help that means for lowa.

The new page replaces the previous "Where The Money Goes" page we'd utilized for a number of years. The details on that previous page focused on the historical use of lottery proceeds since the lowa Lottery's start in 1985. The new page expands on that.

At the top of the new page is a breakdown of each \$1 spent on lottery tickets. The figures currently listed are for fiscal year 2019, and we'll update the details with each new year's results as we have them.

The biggest share of the money in FY 2019 of course went to players, with 62 cents on the dollar going to pay prizes. The second-largest category was proceeds to state causes, with 24 cents on the dollar going directly to lowa programs.

Below those details are graphics that highlight how lottery proceeds help lowa. There are direct links there to websites providing more information about the state programs that receive funding from the lowa Lottery.



At the bottom of the page is a list of the programs that received lottery proceeds in the past, but are no longer current recipients. We hope that by dividing out the current and past uses of lottery proceeds, we're clearly defining how the lowa Lottery makes a difference in lowa.

Sizeable Unclaimed Lottery Prize In Southwest Iowa



A lottery prize of nearly \$75,000 won in southwest lowa will expire in early July if it isn't claimed in time, and the lottery has been sending out reminders about the winning ticket in the hope that we can jog the winner's memory in time!

The winning ticket in the Extreme Green Progressive InstaPlay game was purchased in April at Casey's, 204 Sixth St. in Corning. The ticket won a progressive jackpot that had reached \$74,938.00 in the game on April 6. The prize will expire in early July if it isn't claimed by then.

Players in InstaPlay games must claim their prizes within 90 days of the date they purchased their ticket, so the winner of the prize in Corning has until 4 p.m. on Monday, July 6, to claim it at one of the lowa Lottery's offices.

The money from unclaimed lottery prizes in lowa goes into the lottery's prize pools for future games and promotions, so it will be used to pay prizes, just not those prizes that have expired.

RE: Key Employee Pay Plan and Compensation

The Board approves compensation for Lottery key employees and we're asking you to do that again today. When setting key employee salaries, the Iowa Lottery has been guided by the State of Iowa's approach.

1-Key Employee Pay Plan

The state has approved an across-the-board pay increase for non-contract employees of 2.1% effective with the June 26, 2020 pay period.

We are asking that the Board also approve an across-the-board pay increase of 2.1% for Lottery key employees effective with the June 26, 2020 pay period.

2-Key Employee Compensation

The state has also authorized agencies to grant with-in grade increases, up to 3%, up to the pay grade maximum for employees on their increase eligibility date. Such increases are discretionary and based upon performance.

Overall, the Lottery has budgeted for merit based increases for all eligible employees, and does not intend to exceed that budgeted amount.

The Lottery intends to make decisions on with-in grade increases on an individual basis, based upon performance, for all Lottery key employees.

We are asking the Board for the authority to approve with-in grade increases, up to 3%, for Lottery key employees based upon performance up to the maximum level in the key employee's pay grade, with that raise being available on the increase eligibility date for the eligible key employee.
